Installation of a 5m high acoustic barrier, to replace an existing palisade steel fence, bell mouth in place of the existing dropped kerb as a western access for up to six tanker vehicles per day. Relocation of existing dropped kerb, alongside the following retrospective aspects; installation of 3m high acoustic fence, and replacement of halogen lights with LED Lights.
