Re-rendering and decorating of the facade

Remove the existing rear roof terrace timber balustrading and sun pipes and installation of new aluminium balustrading

c) SDNP/24/02597/LIS - Remains Of Town Wall, Westgate Street, Lewes

Remove friable previous cementitious mortar repairs and repoint in lime mortar. The sections of wall that have blown and are beyond a pointing repair to be removed, clean all areas ready to accept the set aside flints and bricks, relay flints and bricks to closely match existing profile and tilt
