Replacement of patio hardstand to rear side of property with reclaimed Victorian brick pavers.

### SDNP/24/05116/HOUS - 1 Mount Cottages, Castle Banks, Lewes

Installation of solar panelling to rear elevation and air source heat pump, replacement of flat roofs with green roofing, insertion of 3no windows to previously blocked up window openings, and the additions of 1no rear bedroom roof, and 1no window to kitchen, replacement of existing vehicle gate doors with timber gates and replacement of pedestrian gate with timber gate to match.

Conversion of garage to study space by removing garage door and replacing with a wall and 1no window.
